The meeting was presided over by the President and Secretary and the minutes of the meeting with Urbana –BNRI and the representative of owners of the flat held on 26<sup>th</sup> Feb 2016 was discussed one by one with the members present and the comments were noted down as the separate annexure to the meeting. The important points of the meeting were as under:-

- 1. NO PDC required for FITOUT as agreed by the Urbana –BNRI Management
- 2. Declaration to be signed on a plain paper instead of Stamp Paper
- 3. Occupancy Guidelines to be framed with Flat owners representation in the FMC Board
- 4. Club Charges to be transferred in Escrow Account- Modulates to be discussed with Urbana BNRI Management
- 5. Possession to be legally obtained from KMC
- 6. Open Car Park BNRI offered the owners group 150 open car parking for visitors while the owners group have requested "NO OPEN CAR PARKING" or to have a minimum of 200 open car parking for visitors.
- 7. Municipal Taxes/Rent/ Maintenance Charges to be borne by the Urbana BNRI till flat registration formalities are completed with receipt of CC/ OC from KMC.
- 8. Electricity Charges was agreed to be paid at Rs.5000/- till the electric meter is installed.
- 9. Interest @18%p.a for delay in the project by 2 years should be compensated by the Urbana –BNRI Management
- 10. Draft Deed of Conveyance duly vetted by Govt. Dept should be provided to us . The Model agreement should be checked by the Urbana Welfare Association by appointing a lawyer .
- 11. One Qualified engineer to be identified from the group who understands the technical and construction knowledge.
- 12. It was agreed that the MOM dt. 26<sup>th</sup> Feb 2016 shall be signed by one of the Directors from the Urbana Management attending the meeting.
